3. Demand Draft of Rs. 1180/- (Tender form cost Rs.1000/- plus GST Rs.180/-) & Rs. 10,000/- (Earnest money deposit) of Nationalized/schedule Bank in favor of Vasantdada Sugar Institute, Pune towards Tender form fee & EMD separately.
4. Project Management Consultant will have to complete the project within schedule time period. If the Project Management Consultant failed to complete the job, penalty equal 0.5 of cost of contract value per week will be recovered.
